Participants Payment and Refund Policy

- o Full payment is required to reserve a place in the painting workshop
- o Only in exceptional circumstances, an instalment plan can be arranged with full payment to be received 30 days prior the start of the workshop (please email for info)
- o Enrollment is only guaranteed with full payment.
- o A minimum of 10 students is required per workshop. If the minimum is not met 25 days before the start date, the workshop may be cancelled. Participants will be notified via email. A full refund will be issued.
- o If Rossoart cancels the workshop for any reason, participants shall receive a 100% refund.
- o Refunds or Credit notes are only possible if there is a waiting list, and another participant takes that place; then the participant shall receive a full refund less a £100 handling fee.
- o No refund, credits, or transfers will be applied on or after the workshop start date.
- o No refund, credits, or make-up will be offered for missed days.

These terms shall not be reduced or waived in the event of circumstances beyond our control such as illness, flight cancellations, war, terrorist attacks, injury or death, natural disaster or force of nature.
